

Contract Agreement Form

THIS AGREEMENT made the _____ day of **JAN 22 2024** between **City Government of Cagayan de Oro**, of the Philippines (hereinafter called "the Entity") of the one part and **RG Advertising Services** of NCKK Bldg. R-214 Kauswagan Road, Cagayan de Oro City, (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity undertook the negotiation with the Supplier for media services, viz., **Procurement of 1 lot Radio Airtime Broadcast; PR No. 23-4876 dated December 7, 2023** and the Entity accepted the price quotation offered by the Supplier for the supply of the services in the sum of **Six Hundred Thousand and 00/100 Pesos (PhP600,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's submitted Price Quotation;
 - (b) the Schedule of Requirements;
 - (c) the Conditions of Contract;
 - (e) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
