THIS AGREEMENT made this 21 MAR 2023 day of _____, between the **City Government of Cagayan de Oro** of the Philippines (hereinafter called "the Entity") of the one part and **Sabijon Distribution** of B3 Lot 17 & 19, Forest View Homes, Carmen, Cagayan de Oro City, (hereinafter called "the Supplier") of the other part.

WHEREAS the Entity invited Bids for certain goods, viz., **Supply and Delivery of Drugs and Medicines (Lot No. 1); PR No. 22-3927 dated November 14, 2022; SN 292 - 2022**, and has accepted a Bid by the Supplier for the supply of those goods in the sum of **One Million Eight Hundred Twenty Seven Thousand Eight Hundred Fifty and 00/100 Pesos Only (PhP1,827,850.00)**, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - F the Entity's Notification of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract




