
THIS AGREEMENT made this _____ day of JAN 14 2022,
between the **City Government of Cagayan de Oro** of the Philippines
(hereinafter called "the Entity") of the one part and **NAVI Geo -
Construction Corporation** of Casinabe Compound, KM 17, Brgy. Ilang,
Davao City, (hereinafter called "the Supplier") of the other part.

WHEREAS the Entity invited Bids for certain goods, viz., **One (1) Lot Provision of Resistivity Profiling Survey, Geologic Mapping and Engineering Geology and Geologic Hazard Assessment Report (EGGAR) for the 60-Hectare Property at Sitio Patpat, Lumbia; PR No. 21-1033 dated 22 April 2021; SN 127a - 2021**, and has accepted a Bid by the Supplier for the supply of those goods in the sum of **One Million Two Hundred Fifty Thousand and 00/100 Pesos (PhP1,250,000.00)**, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents, as annexed, shall be deemed to form and be read and construed as part of this Agreement, viz.:

- A the Bid Form and the Price Schedule submitted by the Bidder;
 - B the Schedule of Requirements;
 - C the General Conditions of Contract;
 - D the Special Conditions of Contract;
 - E the Performance Security; and
 - F the Entity's Notification of Award.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.






