

THIS AGREEMENT, made this _____ day of FEB 08 2024, between the **City Government of Cagayan de Oro** (hereinafter called "the Entity") and **Sta Ana Raycon Corp.** with office address at B13 L32 Bellevue Subd., Upper Carmen, Cagayan de Oro City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the **Construction of Cugman River Flood Mitigation Structure, F.S. Catanico (Phase 7); SN 223a - 2023**; Contract Reference Number: **10083782** (hereinafter called "the Works") and the Entity has accepted the Bid for **Eight Million Nine Hundred Ninety Eight Thousand Two Hundred Nineteen and 37/100 Pesos Only (PhP8,998,219.37)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - G Addenda and/or Supplemental/Bid Bulletins, if any;
 - H Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
 - I Eligibility requirements, documents and/or statements;
 - J Performance Security;
 - K Credit line issued by a licensed bank, if any;
 - L Notice of Award of Contract and the Bidder's conforme thereto;
 - M Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and

the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
