WHEREAS the Entity invited Service Providers/Contractor (Security Agencies) to submit price quotations for the contract, **Procurement of Security Services; PR No. 23-2934 dated August 15, 2023; RFQ No. 2064-23** and has accepted an offer by the Service Provider/Contractor for the supply of the services in the sum of **Two Hundred Fifty Five Thousand and 00/100 Pesos (PhP255,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's submitted Price Quotation;
  - (b) the Technical Specification and Schedule of Requirements;
  - (c) the Conditions of Contract;
  - (e) the Entity's Notice of Award.
3. In consideration of the payments to be made by the Entity to the Service Provider/Contractor as hereinafter mentioned, the Service Provider/Contractor hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Service Provider/Contractor consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


