

Contract Agreement

THIS AGREEMENT made this _____ day of **JAN 27 2023**, between the **City Government of Cagayan de Oro** of the Philippines (hereinafter called "the Entity") of the one part and **Centramed Phils. Co.** of Lot 24 & 26 Blk 2, Rm. 204 Bagsi Bldg., Dacudao Avenue, Loyola St., Brgy. Paciano Bangoy, Agdao District, Davao City, (hereinafter called "the Supplier") of the other part.

WHEREAS the Entity invited Bids for certain goods, viz., **Supply and Delivery of Various Medical, Dental & Laboratory Supplies (Lot No. 5); PR No. 22-3156 dated September 21, 2022; SN 244 - 2022**, and has accepted a Bid by the Supplier for the supply of those goods in the sum of **Two Hundred Thirty Three Thousand Seven and 00/100 Pesos (PhP233,007.00)**, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
