#### ORDINANCE NO. 13882-2020

AN ORDINANCE FURTHER EXTENDING THE DEADLINE FOR THE PAYMENT OF THE 2<sup>nd</sup> QUARTER TAXES, FEES AND CHARGES TO JUNE 25, 2020, PURSUANT TO DEPARTMENT ORDER NO. 002-2020 DATED APRIL 23, 2020 OF THE DEPARTMENT OF FINANCE AND IN COMPLIANCE WITH RA 11469 (BAYANIHAN TO HEAL AS ONE ACT); AND FOR THIS PURPOSE, AMENDING ORDINANCE NO. 13856-2020 ACCORDINGLY

BE IT ORDAINED by the 19th City Council (Sanaguniana Panlungsod) in session duly assembled that:

SECTION 1. The deadline for the payment of the 2<sup>nd</sup> Quarter taxes, fees and charges is hereby further extended to June 25, 2020, pursuant to Department Order No. 002-2020 dated April 23, 2020 of the Department of Finance and in compliance with RA 11469, otherwise known as the Bayanihan to Heal as One Act.

SECTION 2. For this purpose, no surcharges and penalties shall be collected by the City Treasurer from taxpayers who will be paying their taxes, fees and charges on or before the said deadline.

SECTION 3. Ordinance No. 13856-2020, entitled: An Onlinance Extending the Deadline for the 2<sup>rd</sup> Quarter Installment Payment of Local Business Taxes from April 20, 2020 to May 20, 2020, Conformably with Section 167 of the Local Government Code and RA 11469 (Bayanihan to Heal as One Act), is hereby amended accordingly.

SECTION 4. This Ordinance shall take effect upon its approval.
