RESOLUTION NO. 13572-2020

RESOLUTION EARNESTLY REQUESTING VARIOUS CREDIT COOPERATIVES, PAWNSHOPS AND LENDING/BANKING INSTITUTIONS IN THE CITY TO EXTEND THE DEADLINE PAYMENT OF THEIR CLIENTS'/CUSTOMERS' BILLS OR DUE DATES IN CONSIDERATION OF THE COMMUNITY QUARANTINE PERIOD BEING IMPLEMENTED TO COMBAT THE SPREAD OF COVID-19

Whereas, on March 16, 2020, Mayor Oscar S. Moreno issued an order for the temporary closure of Shopping Malls and other establishments in the City as a necessary preventive action to stop the spread of COVID-19 in the City;

Whereas, thousands of employees especially daily wage, job order or contractual workers will be affected thereby and consequently lose income as a consequence thereof;

Whereas, extending the due dates of credit cooperatives, pawnshops and lending/banking institutions in the City doubly will help in alleviating the burden residents adversely affected of the community quarantine;

Wherefore, on motion by Councilor Ian Mark Q. Nacaya, duly seconded by Councilor Maria Lourdes S. Gaane, be it

Resolved, to earnestly request the various credit cooperatives, pawnshops and lending/banking institutions in the City to extend the deadline payment of their clients'/customers' bills or due dates in consideration of the community quarantine period being implemented to combat the spread of COVID-19;
