THIS AGREEMENT, made this ____ day of 24 OCT 2023, between the **City Government of Cagayan de Oro** (hereinafter called "the Entity") and **Glaxon Construction Services** with office address at Ruby St. Golden Village Subd., Carmen, Cagayan de Oro City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the **Road Opening at Sitio Lerupan to Sitio Tubalon, Pagalungan; SN 162a - 2023**; Contract Reference Number: **9927862** (hereinafter called "the Works") and the Entity has accepted the Bid for **Four Million Nine Hundred Ninety Eight Thousand Three Hundred Sixty Nine and 14/100 Pesos Only (PhP4,998,369.14)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - I Eligibility requirements, documents and/or statements;
 - J Performance Security;
 - K Credit line issued by a licensed bank, if any;
 - L Notice of Award of Contract and the Bidder's conforme thereto;
 - M Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
